## PROCUREMENT OF NON-CONSULTANCY SERVICES

The Government of Myanmar has received financing from the World Bank toward the cost of the Ayeyarwady Integrated River Basin Management (AIRBM) Project, and intends to apply part of the proceeds toward payments under the contracts for River Surveys and Very High Resolution Satellite data for Central and Upper Myanmar.

The non-consultancy services include **Local topographic survey services to support river hydraulic modelling and flood hazard mapping in central and upper Myanmar.**

Ministry of Transport and Communications, Directorate of Water Resources and Improvement of River Systems (DWIR), AIRBM Project, Project Management Unit (PMU) now invites sealed bids from eligible bidders for the non-consultancy services under *River Surveys and Very High Resolution Satellite data for Central and Upper Myanmar contract package.*

To be considered eligible and qualified a firm must:

- a) Have completed within the last 5 years at least three contracts each with at least 50% of the total value of the bid in both topographic and hydrographic surveys, operating in Myanmar or in the region with some experience of delivering projects in Myanmar .
- b) Have project experience in the application of satellite remote sensing to produce very high resolution Digital Elevation Models, GIS, AutoCAD and manipulation of survey data similar to the outputs required in Section 4. Description of the Services.
- c) Have a survey team with minimum qualification as stipulated in Section 4. Description of the Services.
- d) Be a registered company in Myanmar or abroad.
- e) Not be under any notice of disbarment issued by the Government, or the World Bank.

Bidding will be conducted through the Shopping procedures as specified in the World Bank's [\*Guidelines: Procurement of Goods, Works and Non-Consulting Services under IBRD Loans and IDA Credits & Grants by World Bank Borrowers\*](#) dated January 2011 (revised July2014) ("Procurement Guidelines"), and is open to all eligible bidders as defined in the Procurement Guidelines.
