Fiber cable Installation and Transmission for data Network for DMH Office in Nay Pi Taw includes following:

- 1) Supply and installation of Fiber Connections
- 2) Supply and installation of DMH Network infrastructure in Two buildings

Ministry of Transport and Communications, Directorate of Water Resources and Improvement of River Systems (DWIR), AIRBM Project, Project Management Unit (PMU) now invites sealed bids from eligible bidders for **Fiber cable Installation and Transmission for data Network for DMH Office in Nay Pi Taw**.

To be considered eligible and qualified a firm or individual must-

- a) Have completed within the last 3 years at least two contract of a similar nature of at least 50% of the value of the bid;
- b) Have shops or offices in Myanmar to provide after sales services;
- c) Not be under any notice of suspension or debarment issued by the Government, or the World Bank
- d) Have valid company registration certificate

The Goods will be delivered and installed to Nay Pyi Taw Office, No.5, Department of Meteorology and Hydrology (DMH), Ministry of Transports and Communications, Nay Pyi Taw.

Bidding will be conducted through the Shopping procedures as specified in the World Bank's [*Guidelines: Procurement of Goods, Works and Non-Consulting Services under IBRD Loans and IDA Credits & Grants by World Bank Borrowers*](#) dated January 2011 (revised July2014) ("Procurement Guidelines"), and is open to all eligible bidders as defined in the Procurement Guidelines.
