Ministry of Transport and Communications, Directorate of Water Resources and Improvement of River Systems (DWIR), AIRBM Project, Project Management Unit (PMU) now invites sealed bids from eligible bidders for *Supply and Delivery of Acoustic Doppler Current Profiler*.

To be considered eligible and qualified a firm must

- b) Not be under any notice of disbarment issued by the Government, or the World Bank.
- c) Have valid company registration certificate in Myanmar or abroad.
