The Government of Myanmar has received financing from the World Bank toward the cost of the Ayeyarwady Integrated River Basin Management (AIRBM) Project, and intends to apply part of the proceeds toward payments under the contracts for *Hydrographic Survey Services between Nyaung U and Yangon, and Upgrading of the Hydrographic Office*.

The non-consultancy services include **Hydrographic Survey Services between Nyaung U and Yangon, and Upgrading of the Hydrographic Office**.

Ministry of Transport and Communications, Directorate of Water Resources and Improvement of River Systems (DWIR), AIRBM Project, Project Management Unit (PMU) now invites sealed bids from eligible bidders for the non-consultancy services under *Hydrographic Survey Services between Nyaung U and Yangon, and Upgrading of the Hydrographic Office*

To be considered eligible and qualified a firm must:

- a) Have at least 10 year experience in both topographic and hydrographic surveys, and 5 year experience of S57 Chart making;
- b) Have sufficient project experience in acquisition of stereo satellite imagery from high resolution satellite, application of GIS, AutoCAD and manipulation of survey data similar to the outputs required in Section 4. Description of the Services;
- c) Have sufficient project experience in obtaining Chart Data in rivers, transforming GIS data into Hydrographic and marine charts similar to the outputs required in Section 4. Description of the Services;
- d) Have a survey team with minimum qualification as stipulated in Section 4. Description of the Services;
- e) Be a registered company;
- f) Not be under any notice of disbarment issued by the Government, or the World Bank.

Bidding will be conducted through the Shopping procedures as specified in the World Bank's [Guidelines: Procurement of Goods, Works and Non-Consulting Services under IBRD Loans and IDA Credits & Grants by World Bank Borrowers](#) dated January 2011 (revised July 2014) ("Procurement Guidelines"), and is open to all eligible bidders as defined in the Procurement Guidelines.
