The reference number of the Invitation for Bids is:

1. The Republic of the Union of Myanmar has received financing from the World Bank toward the cost of the Ayeyarwady Integrated River Basin Management (AIRBM) Project, and intends to apply part of the proceeds toward payments under the contracts for **Supply and Delivery of Automatic Water Level Recording Equipment**.
2. The AIRBM Project, Project Management Unit (PMU), Directorate of Water Resources and Improvement of River Systems (DWIR), Ministry of Transport and Communications (MoTC) now invites sealed bids from eligible bidders **Automatic Water Level Recording Equipment** to the Department of Meteorology and Hydrology (DMH).

The Bidders shall furnish documentary evidence to demonstrate that they meet the following financial, experience and technical capacity requirements:

- i. Average annual turnover should not be less than: US\$ 500,000 in last three years.
- ii. A form of credit line from a commercial bank or a bank account statement to demonstrate that the Bidder has following amounts available for the respective contracts if awarded to the Bidder: US\$ 500,000.
- iii. The Bidder has successfully completed at least two (2) corresponding contracts including supply, installation and commissioning of similar Goods and Related-Services with the value of such contract not less than (50%) of the bid price for the offer over the last 5 years, and in which the equipment has been operating successfully in accordance to international standards.

If a Bidder is not a manufacturer, but is offering the Goods on behalf of the Manufacturer under Manufacturer's Authorization Form (Section IV, Bidding Forms), the Manufacturer shall demonstrate the above qualifications (i), (ii), (iii) and the Bidder shall demonstrate that it has successfully completed at least two (2) contracts of (Supply, Delivery, Installation and Commissioning) in the past 5 years.

No margin of preference is applicable..

Bidding will be conducted through the International Competitive Bidding procedures as specified in the World Bank's [*Guidelines: Procurement of Goods, Works and Non-Consulting Services under IBRD Loans and IDA Credits & Grants by World Bank Borrowers dated January 2011 \(revised July 2014\)*](#) ("Procurement Guidelines"), and is open to all eligible bidders as defined in the Procurement Guidelines.
